High pressure fresh water wash or fresh water wash, as appropriate, and remove all oil or grease, soluble contaminants and other foreign matter in accordance with SSPC-SP1 solvent cleaning.

NEWBUILDING

Intercept 7000 should always be applied over a recommended primer coating scheme. The primer surface should be dry and free from all contamination, and Intercept 7000 must be applied within the overcoating intervals specified (consult the relevant product data sheet).

Consult the recommended anticorrosive primer system and apply Intercept 7000 within the overcoating interval specified for the primer (consult the relevant primer data sheets).
